Effects of intangible assets such as Technology and assertive leadership on efficient systems in a Cuban Institution

Abstract— In the work field, leaders develop assertiveness to establish their relationship with their employees. However, technology is increasingly opening up in Cuba and stimulates the use of systems platforms such as roads or channels of indirect communication of leaders with their employees. Assertiveness could be influenced by the use of technology and generate a new asset of intangible knowledge. To learn about this relationship, a descriptive non-experimental transactional empirical study was conducted at a Cuban financial institution. Questionnaires and expert judges' criteria were used to analyze the relationships of variables and to triangulate the results. Metrics revealed that there is a significant relationship between the assertive behavior of leaders and the use of technology. It was found that subjects with a high degree of use in technologies developed assertive behaviors in the exercise of their work.

Employee Silence, Organizational Commitment, and Job Burnout of Regular Employees in Local Government Units in the Cotabato Province, Philippines: A Keystone for Intervention

Abstract—The study was a quantitative research that employed descriptive and correlational research designs. It primarily determined if there is a significant association between employee silence, organizational commitment, and job burnout of the regular employees of the selected local government units in District three (3) of the Cotabato province.

Results found out that the degree of employee silence in terms of acquiescent, quiescent, prosocial and opportunistic silence observed by the regular employees of the selected local government units at work was moderate. Furthermore, the findings showed that they also shared a moderate degree of organizational commitment in terms of affective, continuance and normative commitment towards their organization. Lastly, the study determined that they experienced a moderate degree of job burnout in terms of exhaustion, cynicism, and professional inefficacy at work.

Moreover, the research determined a positive yet very low relationship between employee silence and job burnout, while a negative and very low relationship between organizational commitment and job burnout of the regular employees. Lastly, it was verified in the study that none of the dimensions of employee silence and organizational commitment was statistically significantly linked with any of the dimensions of job burnout. Nevertheless, the study concluded that the correlations that were found between the variables and their dimensions were insignificant and statistically due to probability.

Making the study more meaningful for the research respondents, the study recommended an intervention program in the form of development training that the Heads, Supervisors and HRMDO of the concerned offices may use as a keystone in addressing the issues on job burnout that were identified in the study such as feeling strain from working all-day,

emotionally drained from work, and used up at the end of the workday for exhaustion; becoming more cynical about the contributions of their work and less enthusiastic about work for cynicism; inability to solve the problems that arise at work, uncertainty on being effective in getting things done, and unable to feel happy when something was accomplished at work for professional inefficacy.

The Role of Justice and Information Quality in Pharmaceutical Supply Chain

Abstract—This study explored the impact of interactional justice on information quality and logistics performance. Consequently, it categorized interactional justice of pharmaceutical supply chain into interpersonal and informational justice, and empirically sorted the effects of these concepts on information quality and logistics performance. To this end, 500 question sheets were distributed, and 307 valid responses were used for the statistical analysis. Reliability and validity were verifed using SPSS 18.0. and AMOS 18.0. After that, structural equation modeling was used to examined the hypothesis. According to the results of this study, it was shown that interpersonal justice did not have a significant effect on information quality. However, informational justice had a positive influence on information quality. Lastly, information quality had a positive influence on logistics performance. These results imply that if informational justice is not perceived in the seller-buyer relationship, information quality can be obstructed, which negatively impacts logistics performance. Furthermore, the study has massive implications. This is because in addition to academic implications, it provides practical implications for pharmaceutical industry workers. On the other hand, if future studies look at other justices in addition to interactional justice at the same time, it will be able to see the importance of justice in a more macroscopic framework.
